1. Welcome/Call to Order Karla Doyle
Meeting was called to order at 9:30am

2. 2021 Budget Report – Vote for Approval Bill Ciske
Bank Balance - \$38,902.37
Highlights:
2021 income of \$3,323 DNR Grant advancement for EWM control, \$6,950 in membership dues, and \$4,150 in Lake Ecology Fund donations.
2021 Expense of \$17, 711 EWM Control and \$2,250 website upgrade.

2022 Budget highlights include \$10,000 in additional DNR EWM control Grants and \$600 in Oconto County Healthy Waters Grant.
Expense of \$5,000 EWM Control.

3. Eurasian Water Milfoil Treatment Update Ken Schwebke
Ken presented very positive results of the EWM treatment we are seeing both from last year's test and this year's wider spread treatment. He also shared the many hours of work that has been spent by designing and building the curtains, DNR and treatment company coordination to apply the herbicide at the very precise timing, water sampling being done very frequently before and after the treatment and DRN and County Grant applications. 4. High Lake Level Survey

Karla Doyle

80% of the association needed to vote one way or the other.

61% actually voted.

No action will be taken to implement a temporary slow no wake for this year through the Towns of Townsend.

The board did come with suggestion on alternative ideas to make the 250ft slow no wake request more visible and also took suggestions from the floor.

Starting this week we will place the red buoys we used for the EWM treatment in specific locations around the lake with signage showing how far out 250ft is. Also increasing the visibility at the boat landing.

5. New Business

Three board members terms were up this year. Mark Stumpf, Joe Harrison, Ken Schwebke. All agreed to stay on for another 3 year term. We also asked if there were any nominations from the floor and there were none. There was a unanimous vote in favor of electing them for another 3 year term.

Discussion was had around getting more volunteers at the boat landing for inspecting boats and educating people on Clean Boats/Clean Waters. There was also a suggestion to hire someone to do this job. The board will look further into options.

There is grant money available from Oconto County to do projects for shoreline restoration once the water levels start coming back down. Matt Marty and Kathy Wiggins are our Oconto County Lakes and Waterways representatives. They will get more detailed information and work back with the board to communicate options back to the association.
